Acceptance of Terms

By using this web site ("Site"), you acknowledge that you have read and that you agree to be bound by these Terms of Use. Park View Federal Credit Union ("Park View") may change these Terms of Use from time to time in its sole discretion without notice to you. General information. No personal, such as your name or address, is collected automatically when you visit our Site.

Information collected and stored automatically. For Site security purposes and to ensure that this service remains available to all users, Park View utilizes software programs to monitor network traffic to identify unauthorized attempts to upload or change information, or otherwise cause damage.

Site management information is collected for statistical purposes. Computer software programs are used to create summary statistics, which are used for such purposes as assessing what information is of most and least interest, determining technical design specifications, and identifying system performance or problem areas.

Only the following information is automatically collected and stored when you visit our Site:

- The internet domain from which you access our Site.
- The make and model of Internet browser software that you have used when accessing our Site.
- The number of times that you have visited our Site during the current month – Park View utilizes "cookies," a file placed on your hard drive by a website that allows it to monitor your visit. You can set your browser to warn you when placement of a cookie is requested and decide whether to accept it.

Information collected from emails and web forms. We may store these requests to provide us with information for future improvements to our Site. We may forward your email to third parties who provide specific products that you are requesting information about.
