The Program

Park View Federal Credit Union is committed to improving the financial lives of its members. Our financial resources for young adults and the Scholarship Program were created to help members with early financial milestones, such as going to college. Scholarship awards are based on academic achievement and submission of an essay on a topic selected by the Credit Union.

Two (2) \$500 scholarships will be awarded for the 2021-22 academic year. Scholarship recipients will be notified in May 2021 and will be announced to the rest of the Credit Union membership in a future publication. A check will be made payable to the recipient.

Eligibility

- 1. Applicant must be a Park View Federal Credit Union member in good standing. A member in good standing is defined as one with a minimum balance of \$5 in his or her account and no loan delinquencies.
- 2. Applicant must be a graduating high school senior enrolling into a two- or four-year college, or a post-secondary trade or vocational school.
- 3. Applicant must fully complete the Scholarship Application and return it to Park View Federal Credit Union with all appropriate support material by the April 30 deadline for the application to be considered by the committee.
- 4. Park View Federal Credit Union employees, committee members, board members and their immediate family members are not eligible.

How to Apply

- Read all instructions completely and thoroughly.
- Fill out the application and submit the following supporting documents. (Documents must be unstapled and typed or legibly written):
 - □ An official copy of your most recent school transcript including your GPA.
 - □ A 250-500-word essay that answers the essay question found in the following application.
